## **BUILDING PERMITS**

Sec. 18.101 Permits--- It shall be unlawful for any person, whether owner, tenant, agent or contractor, to erect, materially alter or relocate any structure or building intended for human habitation or use, or containing any new plumbing, heating or electrical work, or involving any major alteration of plumbing, heating or electrical work in any existing building or structure, within the Village of Clayton, Illinois, without first having obtained a permit and paying the permit fee therefor. All work done in accordance with such permit shall start within six months and be completed within a period of two years from the date of issuance of such permit or such permit shall expire.

Sec. 18.102 Fees--- Fees for such permit shall be \$25.00 for any new building or structure and \$25.00 for any major alteration, relocation, or addition of or to any structure involving or effecting plumbing, heating or electrical systems.

Sec. 18.104 Penalty--- Any person, firm or corporation violating the provisions of this ordinance shall, upon conviction, be fined a sum not to exceed \$200.00.

# ZONING – ARTICLE 4, "R-1", SINGLE-FAMILY RESIDENTIAL

Section 8 Area Regulations

1. Front Yard:

a. There shall be a front yard having a depth of not less than twenty-five (25) feet or the front yard shall be consistent with the frontage of the existing neighborhood if the frontage of the existing neighborhood is less than twenty-five (25) feet.

b. Where lots have a double frontage, the required front yard shall be provided on both streets.

c. Where a lot is located at the intersection of two (2) or more streets, there shall be a front yard on each side of a corner lot, provided, however, that the buildable width of a lot of record at the time of passage of this ordinance need not be reduced to less than thirty-five (35) feet, except where necessary to provide a yard along a side street with a depth of not less than five (5) feet. No accessory building shall project beyond the front yard line on either street.

#### 2. Side Yard:

Except as provided for in Article 14, there shall be a side yard on each side of a building having a width of not less than five (5) feet or ten (10) percent of the average width of the lot, whichever amount is smaller, provided that no side yard shall have a width of less than three (3) feet.

### 3. Rear Yard:

Except as provided for in Article 14, there shall be a rear yard having a depth of not less than thirty (30) feet or twenty (20) percent of the depth of the lot, whichever amount is smaller.

### Section 9 Intensity of Use

All buildings including accessory buildings shall not cover more than forty (40) percent of the area of the lot. Every "R-1" residential lot shall have an area of not less than seven thousand (7,000) square feet per family, and shall have an average width of not less than fifty (50) feet, except that if a lot of record has less area or width than required and has been duly recorded prior to the date of the passage of this ordinance, such lot may be used for any purpose permitted in the article.
